RECOMMENDATION

That the following recommendation be enacted.

Proposal

Program/Project Title: Art Box Project

Amount of City Funding Required: \$50,000

Fund Type (i.e. General Fund, C&C funds, etc.) General Fund

Anticipated Outcomes: Requested funding changes would affect benefits or services for San José residents, businesses, community groups, etc., as described below: (Use as much space as required.)

A Mural Art Program can be a proactive, preventive approach to help eliminate graffiti. In addition to declining property values, graffiti-prone neighborhoods also suffer from increased rates of other types of crimes, including gang violence. The City of San José spends more than \$1.2 million each year to combat graffiti vandalism on walls and utility boxes.

Communities with similar programs, such as the City of Hayward and City of Livermore, have learned that murals on walls and utility boxes are rarely defaced by graffiti and stimulate a sense of neighborhood pride and collective ownership. In addition to graffiti prevention, a small mural art program serves multiple purposes, including: reducing blight, enhancing the attractiveness and vibrancy of the community, and establishing and fostering partnerships with local artists, businesses, and residents.

<u>I recommend that we allocate \$50,000 to the San José Parks Foundation to continue working with</u> neighborhoods and local artists to initiate art box projects citywide.
