- ❑ Author's TYPED name exactly matches signed name
- ❑ Author's gender circled
- ❑ All signatures are original signatures
- ❑ Text is printed single-spaced, full-justified, standard paragraph form
- ❑ Only standard bullets (•) will be printed and non-standard bullets will be changed to standard bullets
- ❑ You may bold, italicize, and/or underline text
